SINGLE TRADE CLASS – D LICENSE

This license shall authorize the holder to contract for, or obtain permits and inspections for one trade such as, but not limited to, those listed below. Such license may include only one trade and an additional license is required for an additional trade. Each Class “D” license shall be required to have an examinee.

Licenses: Framing, Lath/Stucco/Plaster, Roofing, Concrete placement, Masonry, Elevator, Demolition, Drywall, Sign, Insulation, Irrigation system installer, Fire Systems: Sprinklers, Alarms and Detectors, Grease Hood Suppression system.

<input type="checkbox"/>	Proof of Liability Insurance Follow Section 102.g of the TCBC	<ul style="list-style-type: none"> * \$300,000 / \$600,000 public liability & \$100,000 property damage * List Teller County Building Department as certificate holder * Contain a Cancellation Clause
<input type="checkbox"/>	Proof of Worker’s Compensation Insurance OR waiver if there are NO employees Follow Section 102.g of the TCBC	<ul style="list-style-type: none"> * List Teller County Building Department as certificate holder * Contain a Cancellation Clause * Rejection of Workers Compensation must be filed at the state ***see below for more information***
