**REGISTERED MANUFACTURED, FACTORY BUILT, & MOBILE HOME INSTALLER
 CLASS – MI LICENSE**

This license registration entitles the holder to only contract for, install, and set manufactured, factory built, and mobile homes on the foundation, as installation is defined by C.R.S. § 24-32-3102 (5), pursuant to C.R.S. § 24-32-3101 *et seq.*

◇ Please see the Requirements for a Class-C2 License if you will be acting as the General Contractor for any Manufactured, Factory Built, or Mobile Homes. ◇
