ONSITE WASTEWATER TREATMENT SYSTEM INSTALLATION CONTRACTOR CLASS – SI LICENSE

This license entitles the holder to obtain permits for the installation, alteration, and repair of onsite wastewater treatment systems, in accordance with the Teller County Onsite Wastewater Treatment Regulations. Standards and procedures for issuance, performances and revocation or suspension of the OWTS contractor license are described in, and controlled by, the Teller County Onsite Wastewater Treatment Regulations.
