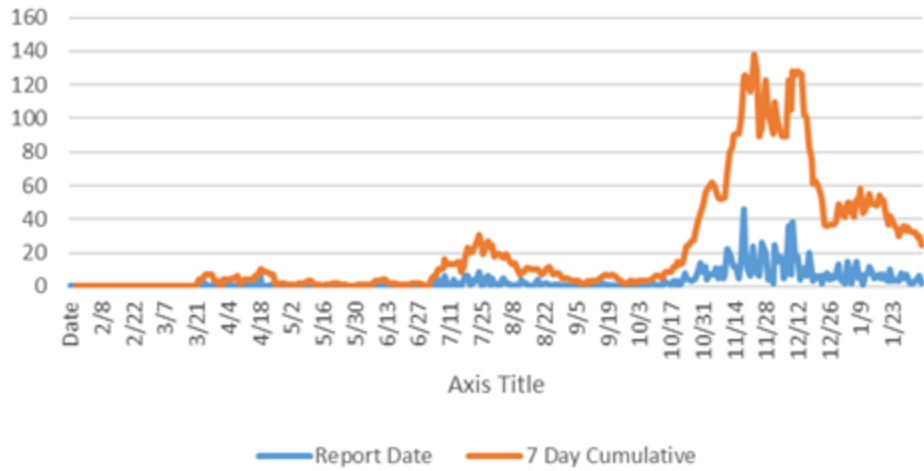

An outbreak remains active until 28 days have passed since last case's symptom onset.

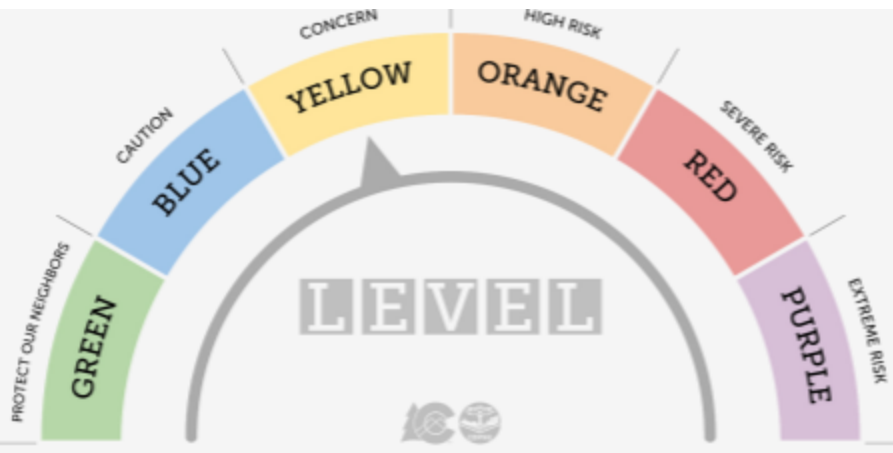

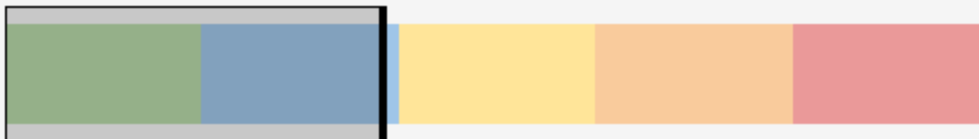

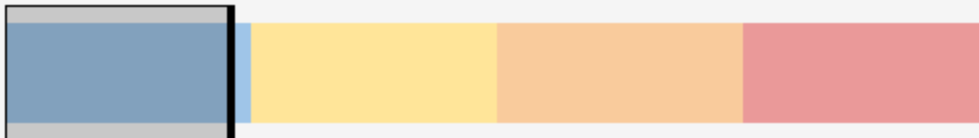
